

**Canada Chinese Computer Association (CCCA)** - an incorporated non-profit organization - was founded in 1993. CCCA's main objective is to promote and protect the interests of its members, the Chinese computer business community in Canada.

The Association is funded entirely by membership fees and income from special events and member services. CCCA's strength lies in its ongoing communication and networking among its members. The Association regularly organizes meetings, social functions and charity events.

There are three classes of members:

(a) **Voting Member.** Any business entity duly registered and with a registered address in Canada and controlled by Chinese interested in furthering the Objectives of the Corporation and engaged in the manufacturing, distribution, sale or servicing of computer or computer related products or computer related services, and approved by the Board shall be eligible for membership as a Voting Member on approval of the membership application by the Board and the payment of such dues and fees as the Board may determine from time to time.

(b) **Sponsor Member.** Any business entity interested in furthering the Objectives of the Corporation and approved by the Board shall be eligible for membership as Sponsor Member on approval of the membership application by the Board and the payment of such dues and fees as the Board may determine from time to time. Sponsor Members shall have no rights to vote. The rights of Sponsor Members shall be limited to such rights as the Board may define from time to time.

(c) **Media Member.** Any business entity interested in furthering the Objectives of the Corporation and engaged in the business of mass communications shall be eligible for membership as a Media Member on approval of the membership application by the Board and the payment of such dues and fees as the Board may determine from time to time. Media Members shall have no rights to vote. The rights of Media Members shall be limited to such rights as the Board may define from time to time.

The Board shall retain at all times the right, power and authority to exercise absolute discretion to approve, refuse, suspend or terminate a membership.
